### 1. Eligibility

- 1.1 Hong Kong young people aged between 18 and 35 years old;
- 1.2With a valid permit to work in Hong Kong (if applicable).

### 2. Programme Details

- 2.1Successful applicants will be required to attend workshops including teaming workshop, business plan writing and idea development workshop. By the mean time, the Applicants will form team of 2 to 3 people with at least one of them underprivileged youth (Definition please refer point 5) to prepare for their business plan;
- 2.2Selected business plans will be granted HK\$50,000 per business and be provided with other business support to execute their ideas immediately for at least one year.

### 3. Application Procedures

  <u>before 26 Aug 2015</u> by email. Please state "Application for STEP" in the email subject;
- 3.3Shortlisted applicants will be required to attend an interview.

### 4. Judging Criteria

- 4.1 The Judging Criteria include (not limited to):
  - Applicants' Readiness (e.g. skills and personality)
  - Personality
  - Availability (e.g. Time)
  - Understanding of Business
  - Innovation
  - Social Awareness
  - Presentation

#### 5. Pilot Seed Fund

5.1 Applicants from grassroots families or are underprivileged may apply for \$7000 "Pilot Seed Fund";

- 5.2Applicants will self-declare their status and needs for the judging panel's consideration. No supporting documents are required at this stage but Applicants may be requested to provide them later. The judging panel may consider the following situation (not limited to):
  - Highest level of education has not yet attained a Bachelor's Degree;
  - Holder of a valid "Registration Card for Persons with Disabilities";
  - Monthly family income is lower than the median (4<sup>th</sup> quarter 2014)<sup>2</sup>;
  - In a family receiving "Comprehensive Social Security Assistance (CSSA) Scheme" (past 12 months);
  - A recipient (the Applicant / a person of the domestic household\*) of the "Normal Disability Allowance" (past 12 months):
  - A recipient (the Applicant / a person of the domestic household\*) of "Work Incentive Transport Subsidy Scheme" (past 12 months);
  - In a domestic household\* receiving "Living subsidy for non-public housing and non-CSSA households" (past 12 months);
  - A recipient (the Applicant / a person of the domestic household\*) of the "Tertiary Student Finance Scheme Publicly-funded Programmes" in the form of a grant and/or loan in this academic year;
  - A recipient (the Applicant / a person of the domestic household\*) of the "the School Textbook Assistance Scheme", "Student Travel Subsidy Scheme" or "Subsidy Scheme for Internet Access Charges" in this academic year;
  - Others, please specify.

(\*A domestic household consists of a group of persons who live together and make common provision for essentials for living. These persons need not be related.)
