Besides, Eric is constantly invited to give speeches in colleges and regularly interviewed by major media of Hong Kong. He is also an article writer for many famous newspaper and journals on topics concerning IT industry and youth issues. Devoting himself to various types of community service, Eric endeavors to promote technology innovation and encourage the youth to contribute to the society.

GTO specializes in Startup mentorship, go to market for entrepreneurs in Silicon Valley, China and Latin Americas. Leslie is also a co-producer of Battle Silicon, award-winning reality TV series for technology startup in the Silicon Valley. In recent years, Leslie is the USA Consultant for Hong Kong Cyberport.

Leslie has more than two decades of business experience in globalization marketing and sales management with Eastman Kodak Company, Lionbridge Technologies (Nasdaq: LIOX) and VanceInfo (Nasdaq:PACT). A Hong Kong native, Leslie has deep understanding of both Western and Asian cultures.

In 2013, Leslie serves as Advisor at Hua Yuan Science and Technology Association (HYSTA), a nineteen-year old Silicon Valley-based nonprofit organization that bridges opportunities and mentors business endeavors between the US and China. In 2012, Leslie was the Executive Director where he played a key role in branding and promoting HYSTA. He also fostered the partnership with 21st Century Media, elevating HYSTA to become the sole strategic partner in the USA for the Top-Ten Global Chinese Business Leader Award Ceremony in Beijing. During his tenure, Leslie co-founded China Global Services Alliance, comprised of members from top-tier China and US-based IT consulting and service providers. Within 12 months, two member companies Isoftstone (Nasdaq:IIS) and Hisoft (Nasdaq:HSFT) went IPO in the USA.
